Work specification (and Technical specifications)	<p>Project Background</p> <p>The South African National Energy Development Institute (SANEDI) is a schedule 3A state owned entity established as an agency of the Department of Mineral Resources and Energy (DMRE). Its mandate is to direct, monitor and conduct energy research and development, promote applied energy research and technology innovation, and undertake measures to promote the uptake of green energy and energy efficiency throughout the economy.</p> <p>SANEDI's contract for annual supply of water and rental of water dispensers has reached its lifespan and there is need to put a new contract in place.</p> <p>Scope of works</p> <p>The SANEDI is looking to appoint a service provider for rental and maintenance of water dispensers as well as weekly supply of water refill bottles.
