2. BACKGROUND

On 8 December 2020 the Minister of Mineral Resources and Energy under section 19(1) (b) of the National Energy Act, 34 of 2008 promulgated the regulations for the Mandatory Display and Submission of Energy Performance Certificates for Buildings. Making it compulsory for buildings owned, occupied and operated by an organ of state with a minimum floor area of 1000m2 and those not owned by an organ of state with a minimum floor area of 2000m2.

Secondly, the regulations were further amended on 25 November 2022 to extend the compliance date to 7 December 2025. On 3 August 2024, a second amendment to the regulation was promulgated introducing compulsory registration of buildings into the National Building Energy Performance Register (NBEPR) and amended the definition of an energy Performance Certificate to a certificate issued by an accredited body prior to 31 July 2024, thereafter by a registered professional in accordance with SANS 1544:2014.

A registered professional is an individual who is registered at the South African National Energy Development Institute (SANEDI).

SANEDI also hosts, manages and maintains the National Building Energy Performance Register (NBEPR), which has all buildings' and EPC data.

Lastly, the buildings that the refers to must be in operation for two (2) years or longer and must not have been subjected to major renovations. The buildings must also fall under the following occupancy classes:

- A1 -Entertainment and public assembly
- A2 Theatrical and indoor sport
- A3 Places of instruction
- G1 Offices

3. INVITATION FOR EXPRESSION OF INTEREST

The Department of Mineral Resources and Energy (DMRE) and the South African National Energy Development Institute (SANEDI), would like to invite Expressions of Interest (EOIs) from training providers focusing on energy performance assessments, ISO/IEC 17020, energy auditing and energy management for individuals who intend on becoming a registered professional at SANEDI.

Expressions of interest (EOI) are hereby invited from suitably qualified training providers to be prequalified/endorsed by SANEDI for the provision of energy performance assessments, ISO/IEC 17020, energy auditing and energy management modules/courses. Respondents are required to submit EOIs to provide all-inclusive information based on the scope of work of this EOI.

Only companies with demonstrable knowledge and experience within the identified scope of work will be considered. Respondents may submit an EOI for individual competencies or can do so. Submissions will be scored according to specific Evaluation Criteria.
