Work specification (and Technical specifications)	<p>Project Background</p> <p>The South African National Energy Development Institute (SANEDI) is a schedule 3A state owned entity established as an agency of the Department of Mineral Resources and Energy (DMRE). Its mandate is to direct, monitor and conduct energy research and development, promote applied energy research and technology innovation, and undertake measures to promote the uptake of green energy and energy efficiency throughout the economy.</p> <p>SANEDI is in the process of applying for SANAS accreditation to become an energy Monitoring and Verification body. This process is now at an advanced stage and requires the training of Energy Efficiency staff who will be essential for the operation of this division. As part of the SANAS accreditation process, relevant employees of SANEDI will have to undergo training in various recommended courses. The Energy Performance Certificate (EPC) is one of these courses that will be required.</p> <p>Scope of works</p> <p>The service provider must provide the following:</p> <ul style="list-style-type: none"> • Training course for 6 employees on Energy Performance Certificate (EPC) at SANEDI, CEF House, Block C, 152 Anne Crescent, Upper Graystone Office Park, Strathaven, Sandton • Training manuals. Required qualifications and experience (Technical Evaluation Criteria)

The bids received will be evaluated in two stages. The first stage will be the pre-condition compliance and technical evaluation, the second the financial/BEE evaluation. The following are the evaluation criteria that all bids will be assessed against:

1. I understand that the accompanying bid will be disqualified if this Certificate is found not to be true and complete in every respect;
2. I am authorized by the bidder to sign this Certificate, and to submit the accompanying bid, on behalf of the bidder;
3. Each person whose signature appears on the accompanying bid has been authorized by the bidder to determine the terms of, and to sign the bid, on behalf of the bidder;
4. For the purposes of this Certificate and the accompanying bid, I understand that the word “competitor” shall include any individual or organization, other than the bidder, whether or not affiliated with the bidder, who:
