3. Scope of works/Technical specifications

3.1 Background

The focus of the project is to install applicable **indirect high-pressure SWH technology** designed to function under extreme hard water quality onto domestic, military housing. The extent of the full site boundary (number of buildings) and the number of units to be installed is as follows: one military base and 50 family homes.

There are various technologies available for domestic water heating, however, in areas where only “hard water” is available, heat causes a calcium build up (known as calcification) much faster, causing damage and reducing the lifespan of hardware especially electrical geysers. This results in high costs for fitment and replacement of technology that is not reaching its projected lifetime of service.

SANEDI is seeking a tried and tested **indirect high-pressure SWH technology** that is commercially available and that has specifically been tested and performs well under extreme hard water conditions. The technology is expected to be resistant to calcification and thus offer a longer lifespan (meeting 5 year guarantee) still delivering hot water to domestic residences.

It must also be noted that while the DOD is regularly undertaking installation, maintenance and repair of water heating infrastructure at its installations/bases, this project aims to support and build capacity in this space for the DOD and its Members. This can be achieved by implementing an energy efficient, renewable energy hardware system that supports human capacity development (HCD) during installation and maintenance, as well as contributing towards reduced energy costs and reliable water heating energy security for the DOD.

3.2 Scope of Work

PRODUCT SUPPLY, TRAINING & INSTALLATION

SANEDI is seeking an experienced service provider that can recommend, design and install the appropriate hard water tolerant indirect SWH systems, while delivering training to DOD members, as part of a full-wrap service offering in compliance with the below.

The product proposed in response to this tender will be used in experimental monitoring by SANEDI to determine SWH technology that is fit for purpose, and to feed into policy recommendations, thus able to be recommended for extreme hard water environments. As such the technology should have the following characteristics:

- The domestic SWH system **MUST** be an **indirect high-pressure system**
- Preference will be given to a vessel with an **indirect internal coil heat exchanger**, above a heat jacket
- It is important to note that this military installation has used pre-feed water filters in the past and this has proven to be ineffective and too costly.
- While not prohibiting the use of filters, this would need to be installed in conjunction with an indirect high pressure system meeting the criteria above. It would also need to be fully covered by the maintenance plan over the 5 years.

Minimum requirement for bid to be considered for Product Supply:

- The product must be designed and guaranteed to perform under hard water conditions, this means it must be a robust indirect high-pressure thermosiphon system as described above
- The service provider must provide a preliminary design of the installation including temperature range and operation provided by the unit
- The service provider must supply services under full wrap (full EPC)
- The service provider must supply a minimum 5-year O&M agreement inclusive of training during O&M
- The technology provider must issue a 5-year (60 month) warranty on the assembled/combined system equipment/hardware

The deliverables for the project will be the following:

- Basic preliminary design of the indirect high-pressure thermosiphon system to be implemented
- A detailed costing for the system to be extrapolated across 50 households
- Project programme including project timeline and project handover date (Gantt Chart)
- An O&M manual
- Detailed training plan for SANDF artisan training
- Hands on installation and operation training for a maximum of 10 SANDF artisans
- Ensure the health and safety of all labour employed in accordance with applicable legislation
- Project inception, progress and closeout meetings between the service provider, SANEDI and the SANDF (as per point 8.)

Additional conditions to consider when implementing this project include:

- All contractor labour involved in the project is exclusive to South African Citizens and/or Permanent Residents
- Military Security (MS) compliance must be ensured for all civilian persons involved in the project/s
 - Requirement for the winning bidder company to be security cleared by Defence Intelligence, otherwise contract is void
 - Requirement for the winning bidder company personnel who will be operating on site, to be security cleared by Defence Intelligence, otherwise contract is void
- Contractors must use identifiable uniform when on military installations
- The DOD and SANEDI are indemnified at all times against contractor loss or injury of any kind
- All fittings (such as doors, pipelines, door frames, verandas, steps, fire hydrants, reels and hoses, walkways, paving, windows, window panes, fascia boards, ceilings, awnings, mushroom fans, etc.) and appliances (such as air conditioners, geysers, gas bottle cages, light fittings, etc.) must be accordingly protected and insured against all risks during construction
- All waste as a result of on-site project execution and material storage must be responsibly removed, managed and disposed of in line with regulation by the appointed contractor
- All associated wastes, packaging, solvents and solutions, shall be disposed in accordance with applicable regulations (not in drainage systems/waste water systems or septic tanks).

- Military will make a securable storage facility available to the appointed contractor for storage of on-site equipment etc.

3.3 Project Management

The project shall be managed through SANEDI by the RECORD Centre Manager acting as the Owners Engineer, and shall include a Project Oversight Committee as follows:

- a) Chaired by RECORD Centre Manager
- b) A technical representative from SANEDI
- c) A representative or more from the contractor
- d) A representative from the SANDF Limpopo Regional Works Unit
- e) A representative from the SANDF target installation
- f) A quorum shall be deemed when one member from each entity is present

Any project related decisions raised by any party associated with the project compliance and physical installation of the system must be addressed through the SANEDI project manager directly as the contracting party.

The Project Oversight Committee shall meet as follows:

- a) On-site inception meeting, to initiate the Project
- b) Thereafter, progress meetings as deemed necessary
- c) A final closure meeting after project completion
- d) Project closeout meeting.

5. Project Schedule

The project shall be completed within 12 months from the last date of signature to the contract. Any deviations from this will need written motivation to SANEDI.

4. Evaluation Criteria

The bids received will be evaluated in two stages. The first stage will be the technical evaluation, the second the financial/BEE evaluation. The following are the evaluation criteria that all bids will be assessed against.

5 Tax Clearance Requirements

14.	It is a condition of bid that the taxes of the successful bidder must be in order, or that satisfactory arrangements have been made with South African Revenue Service (SARS) to meet the bidder's tax obligations.

6.1.3 Key Personnel

6.2 Technical Proposal & Methodology Statement

7.2.1 Solution Statement

The **Solution Statement and Methodology** must respond to the scope of work and outline the proposed technical solution offered. This technical solution statement should articulate what value add the tenderer will provide in achieving the stated objectives for the project and detail the time frames and proposed methodology.

The layout of the solution statement and Methodology should be such that it mirrors the headings contained in the Scope of Works, Section 6 of this Bid Document.

The tenderer must as such explain his / her understanding of the objectives of the assignment and the Employer’s stated and implied requirements, highlight the issues of importance, and explain the technical approach they would adopt to address them. The document should explain the technical attributes and contain specifications of all equipment proposed, to demonstrate the compatibility and capability of the solution. The technical paper should also include a quality plan which outlines processes, procedures for the testing and verification of deliverables, and meet the requirements and indicate how risks will be managed and what contribution can be made regarding value management. The Methodology statement must also include an activity Gantt reflecting a work breakdown structure.
